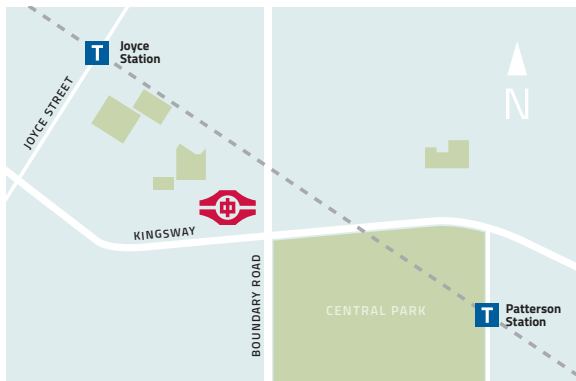

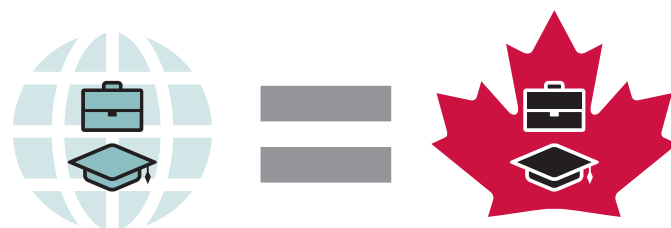

Foreign credential recognition (FCR) is the process of verifying that the education and job experience obtained in another country are equal to the standards established for Canadian workers.



**Eligible Costs:**

The FCR loan can be used to cover the following costs:

Bridging programs	Exam fees with professional associations
Qualification assessments	Professional association fees
Books and course materials	Occupation-specific skills enhancement

**The FCR Loan Project features:**

- Individualized support and guidance;
- Job market navigation;
- Financial support; and
- Mentoring & coaching.

**Client Eligibility:**

Internationally trained professional who meets the following criteria:

- Is a permanent resident, Canadian citizen or an individual granted refugee status in Canada and who is legally permitted to work in Canada;
- Has obtained credentials outside of Canada; and
- Is seeking to have his or her credentials recognized in Canada or is undertaking training for an alternative career, or both.
